4. In case, if remedial lectures are planned and conducted, invite applications from students, maintain records of sessions, show outcome through comparison of consecutive results.


Overall the committee appreciated the documents maintained for various activities planned and conducted in FE.




The committee reviewed the documentation system in FE and extended following remarks.

5. Attainment should be based on target results planned.


