### **ICEM Scholarship Policy**

**Policy Statement :**ICEM has announced scholarship to Meritorious students getting admitted through CAP rounds for admissions from July 2020.

As per this policy the students securing admission to First Year Engineering (FE) and Direct Second year Engineering(DSE) from Mechanical and Civil Department will avail the scholarship. The proportion of scholarship will vary depending upon the category for admission and the proportion of scholarship is also subject to revision on each academic year.

From Year 20-21 the proportion of these scholarships has been decided as follows,

Category	FE	DSE
Open	35 % of FRA	30% of FRA*
OBC	35 % of FRA	30% of FRA
SC/ST/VJ/NT	Government Scholarship	Government Scholarship

As per the policy,

- 1. List of eligible students will be finalized based on their merit, category of admission and branch, year of admission.
- 2. All eligible students of FE and DSE admission of the particular year will be handed over with the set of scholarship certificates of entire course i.e. 4 certificates of each consecutive academic year to FE students and 3 certificates of each consecutive academic year to DSE students.
- 3. The certificates are to be produced by the students to accounts department during their admission to their respective course/year.
- 4. In case any student availing ICEM scholarship fails to make entry to consecutive academic year based on the university results, the scholarship scheme is auto terminated, and the student will have to pay full fees as applicable.
- 5. The format of the certificate that students will be producing is as shown, it consists of
  - i. Mention of Academic year to which the students is seeking admission
  - ii. Name of the student
  - iii. ICEM Scholarship certificate Number (Unique)
  - iv. Bar code identifier
  - v. The Entry year of the student and branch of admission (FE Mech /DSE Mech /FE Civil /DSE Civil)
  - vi. The proportion (amount of scholarship) awarded
  - vii. Terms and Conditions of scholarship scheme:
    - a. The certificate is not transferrable
    - b. Valid for the current (Mentioned) AY only.
    - c. Scholarship amount will be debited from total payable fees.
  - viii. Seals and signatures of authorities

ix. Perforated receipt of acknowledgement to be handed over to student in acknowledgement of the application of scheme (counterfoil of perforated certificate)



On receipt of the particular years certificate the accounts shall cross verify the information with university results copy to make the scheme active to particular student.

Shall provide the certificate number on receipt of student to identify ICEM scholarship case and shall preserve the certificate copy with them for future reference and for audit purpose.

\*The nature of the ICEM scholarship is temporary in nature and the proportions are subject to revision as per the management decision every year.

#### **Government Announced Schemes:**

- 1. The eligible students have to apply for the requisite scheme along with required set of documents.
- 2. The applications are scrutinized and verified for eligibility and scholarship/free ships are granted by respective department.
- 3. The entire process of application, scrutiny, validation and subsequent approvals is online and transparent.
- 4. As per scheme the payments are issued by respective department of the government to institute or to the students as applicable.

#### A. Post-Matric Tuition Fee and Examination Fee (Free ship)

# **Department Name: Social Justice and Special Assistance Benefits**

• Tuition Fees, Exam Fees & other fees which are mandatory or compulsorily payable by the student to the institution are covered under the scheme.

### **Eligibility**

- The parents / Guardian annual income above Rs. 250000.to unlimited.
- Student category should be Scheduled caste or Neo Buddhist
- Student should be resident of Maharashtra
- Student should be passes SSC/equivalent Matric.
- Institute should be located in Maharashtra & shall be government recognized.
- For Professional Courses student should admit through CAP round only
- Only 1 Failure is allowed in whole curriculum.

#### B. Maintenance Allowance for student Studying in professional courses

### **Department Name: Social Justice and Special Assistance Overview**

1) Benefits of maintenance allowance are paid to SC Students studying in professional courses and living in hostel attached to professional colleges.

### **Eligibility**

- Student should be admitted in professional Course.
- Students should be the scholarship holder of Government of India
- The limit of income will be applicable as per the Government of India scholarship scheme i.e. annual income limit less than or equal to 2.5 lac
- Students who are studying in the professional curriculum and residing in Hostel (Government, or Institutes Hostel or outside).

#### **Benefits**

Tuition Fee and Exam Fees As per approved college fee structure

#### **Eligibility**

Applicable for ST only

- \* Family annual income limit is RS. > 2,50,000 Renewal Policy : The student have to pass the previous year examination
- \* If student fails in any year then he is not paid the scholarship for that particular year

- e) Candidate should be admitted through Centralized Admission Process (CAP).
- f) Applicant should not avail any other scholarship/stipend.

### **Department Name: Department of Technical Education**

#### Overview

This is a plan for students of government, government funded and non-affiliated colleges / polytechnics entering the vocational courses set by the government, whose students are certified by the competent authority, as a marginal farmers or whose parents are registered laborers.

#### **Benefits**

- a) For child of Registered Labor / Alpabhudharak (Marginal Land Holder).
- For institute in MMRDA / PMRDA / Aurangabad City / Nagpur City-  $Rs.30,\!000\!/\!\text{-}$  for 10 months.
- For institute in other area Rs.20,000/- for 10 months.
- b) For Annual Family income up to 8 Lakhs.
- For institute in MMRDA / PMRDA/ Aurangabad City / Nagpur City-  $Rs.10,\!000\!/\!\text{-}$  for 10 months.
- For Institute in other area Rs.8,000/- for 10 months.

#### **Eligibility**

Eligibility Criteria: (As per the GR Dated 07th Oct 2017, 22nd Feb 2018, 01st March 2018, 18th June 2018, 11th July 2019)

- a) Applicant should have Nationality of India.
- b) Candidate should be Domicile of Maharashtra State.
- c) Applicant should be "Bonafide Student of Institute" and admitted for Professional and Technical course (Diploma / Graduation / Post Graduation Degree) as mentioned in GR

- d) Deemed University and Private university is not applicable
- e) Candidate should be admitted through Centralized Admission Process (CAP).
- f) Applicant should not avail any other scholarship/stipend.
- g) For current Academic Year, Only 2 child from family are allowed for benefit of scheme.
- h) The Total Annual Income of Family / Guardian should not be more than 8 Lakhs.
- i) Minimum 50 % attendance in previous semester (Exception for fresh admitted in College).
- j) During course duration, candidate should not have a gap of 2 or more than 2 years.
- K) Candidates are eligible those who have taken an admission under General category and SEBC Category

### **Renewal Policy**

### **Documents Required**

- b) Domicile Certificate of Maharashtra State.
- c) Register Labor Certificate / Alpabhudharak (Marginal Land Holder) Certificate (In case of not a child of Alpabudharak or Registered Labour then family Annual Income Certificate).
- d) Undertaking "In current year, not more than 2 beneficiary from family".
- e) CAP Related document.
- f) Hosteller documents (In case of private hostel or Paying Guest, Agreement with owner will be required.

### F. Tuition Fees and Examination Fees to VJNT Students

### Department Name: VJNT,OBC and SBC Welfare Department.

#### Overview

- Create interest in education among students.
- Making financial assistance available for higher education.
- Creating opportunities for financial growth through higher education.
- Scholarship scheme to avoid transparency, unity and delay.
- All types of compulsory fees such as Tuition fees, Exam Fees and other admissible fees are reimbursed to the concern VJNT category students..

#### **Benefits**

- 1) Tuition fees and Exam Fees reimbursed to the concern Applicant vide Govt. Resolution dated 12/3/2007, since 2006-07 the Applicants who are admitted in professional courses through CAP round in the Govt., Govt. approved private non aided and permanently non granted colleges are applicable to pay 100 % Tuition Fees & Exam Fees approved by Education Fee Committee..
- 2) Also those applicants are taken admission in Deemed University for professional courses won't get benefit of scholarship / freeship.
- 3) Start date of application is depending upon the applicant takes admission in college/Institute and End date of application is depend upon the last date of examination.(For 10 months it will vary every academic year on admission date)

### **Eligibility**

- 1) Applicant must be taking post matric education.
- 2) Applicant should be belongs to VJNT category.
- 3) Parent's annual income should be less than or equal to 8.00 Lacs.

- 4) Applicants must be residents of Maharashtra.
- 5) Applicants should be pursuing the education course approved by the government for Post Matric courses.
- 6) Applicant must be taken admission in government government aided / Private Non-Aided / private permanently non aided for professional courses
- 7) Degree Courses in Health Science(Medical, Dental, Homeopathy, Unani, Ayurveda, Physiotherapy, Business Aid, Nursing):
- If Applicant is admitted through Association of Managements of Unaided Private Medical and Dental Colleges entrance examination or admitted through government common entrance examination then he/she will be eligible the for the freeship.
- 8) Higher and Technical Education Department:

Freeship will be applicable to unaided colleges / government and aided colleges with technical education / Polytechnic and government unaided professional courses.

Following are the applicable courses for this scheme:

- Diploma Engineering, Pharmacology, HMCT
- Degree Engineering, Pharmacology, HMCT
- Post Graduate –MBA/MMS, MCA
- 9) For professional courses Applicant should admitted through CAP round is must.
- 10) If Applicant fails in particular year then he will get the Tuition Fees and Exam Fees of that particular academic year but he/she will not get the benefit until he/she gets promoted to next higher class..
- 11) Applicant will be eligible for scholarship if he / she change the course Non Professional to Professional but he will not be eligible if he / she change the course from Professional to Non Professional.
- 12) If an applicant pursuing professional course admitted in private un aided/permanently un aided institute for year 2015-16 onwards fails in the examination two or more times in particular academic course duration then he / she not eligible for the freeship.
- 13) Scholarships/freeship will continue until Applicant completes one course. Ex. 11th, 12th Arts B.A., M.A., M.Phil., P.H.D. If, Applicant completed B.A and B.Ed. course and later after taking admission for M.A., for M.A. course He/she will not be allowed for scholarship/freeship. But after admission to M.B.A. after B.Ed, it can be eligible for scholarship/freeship as it is a professional postgraduate course.
- 14) Applicant studying in particular professional/Non-Professional course, and availing benefits of scholarship/freeship for that academic course and if he/she wants to change his existing Professional/Non-Professional course in between academic years he/she will not be eligible for freeship/scholarship for further course.

#### **Renewal Policy**

- 1) Applicant need to provide previous years marksheet.
- 2) At a time applicant can apply freeship for only one educational course and it will be applicable till he/she completes that educational course in specified time.
- 3) Applicant cannot take freeship for more than 2 professional courses.
- 4) If due to any medical condition or due to any unforeseeable event the Applicant cannot appear in the annual examination, the head master of the college can approve or certify that if the Applicant would have appeared in the annual examination, he would have been able to pass the examination. This will be only allowed if the head of the institution is satisfied
